1. A Bank Statement (Must be current within 3 months of semester start date showing recent transactions i.e. debits, withdrawals, etc...)
2. An Affidavit of Support Form (can be downloaded from website, this form is to be completed by the financial sponsor and the sponsor's bank. Totals on bank statements must match totals on Affidavit of Support.)
